



RELEASE AND WAIVER OF LIABILITY, INDEMNITY AND HOLD HARMLESS AGREEMENT

The undersigned wish to use certain lands of Rayonier Inc., its subsidiaries, and subsidiaries thereof, its parent entities, subsidiaries, and affiliates, and their agents, managers, partners, employees, contractors, invitees, licensees and guest, hereinafter referred to as the "Released Parties", for tour, visitation and/or educational purposes and recognize that such lands are used primarily for the business purposes of the Released Parties and that the undersigned in using them might be injured or their property might be damaged, either by negligent or non-negligent behavior of others including but not limited to the Released Parties. The undersigned hereby acknowledges that such risk of injury includes but is not limited to dangers involving the usual hunting risks, including but not limited to firearms, uneven land and roads, falls, vehicle mishaps, and the actions or failures to act of other people. In view of these facts the undersigned, for valuable consideration, the receipt and sufficiency of which are acknowledged, unless caused by the sole negligence (for the State of Georgia, gross negligence or willful and wanton misconduct) of the Released Parties, hereby releases the Released Parties, waives all claims against any of them, and agrees to defend, indemnify and hold harmless the Released Parties from any and all liability (including attorneys' fees) hereafter arising on account of damage, injury or death of the undersigned and damage or injury (including but not limited to environmental damages) to their property or to the property of the Released Parties or any third party HOWEVER CAUSED, INCLUDING WITHOUT LIMITATION RESULTING FROM THE NEGLIGENCE OF ANY PERSON, INCLUDING THE RELEASED PARTIES, OR OTHERWISE CAUSED during the use of the Lands of any of the Released Parties by the undersigned.

IN ADDITION, the undersigned agrees to abide by and follow any and all directions, information, comments or other statements of the Released Parties to access to the lands or associated activities, including any and all safety suggestions and requirements.

THE UNDERSIGNED SPECIFICALLY ACKNOWLEDGES THAT HE/SHE HAS READ AND UNDERSTAND THIS DOCUMENT AND RECOGNIZES THAT BY SIGNING THIS DOCUMENT HE/SHE (i) RELEASES OTHERS (INCLUDING BUT NOT LIMITED TO THE RELEASED PARTIES), WAIVES HIS/HER CLAIMS AGAINST THEM, AND AGREES TO DEFEND AND INDEMNIFY THE RELEASED PARTIES AND HOLD THEM HARMLESS FROM THEIR OWN NEGLIGENCE (EXCEPT THE SOLE NEGLIGENCE OF THE RELEASED PARTIES) AND AGAINST SAID OTHERS THAT MIGHT RESULT IN DAMAGE, INJURY OR DEATH TO THE UNDERSIGNED OR THEIR OR OTHER'S PROPERTY.

Where applicable, the undersigned adults affirm that they are either the natural parents or guardians of any children that visit the lands covered by this agreement and that they, by signing this release and waiver, are also signing by, for and on behalf of those children.
